A Message From the President

"It has become increasingly apparent that no year in the storied history of the OIF may have a greater, broader impact than 2020."



I wrote that. A year ago. Seems like an eternity. Sounds negative now but it was never meant to carry that connotation, only a reflection of the uncertainty we were all facing. The OIF, like the entire OI community and the rest of the world, was at a crossroads. While we were kicking off the OIF's golden anniversary, the experts were marking the so-called 'peak of the pandemic.' Much has changed in the intervening year and a great deal of uncertainty remains, but we've learned so much, especially from each other.

I don't think any of us knew what we were dealing with at the time, much less when it might end. But as a Foundation and a community, we knew we had to ascertain the knowledge to properly address individual and collective concerns, and we knew we needed to invest in outreach in a manner and capacity like never before. If not, the very future of the OIF was at stake. I'll be brutally honest: we were worried. But as board presidents before me have noted time and again, this community is a collection of miracle workers, selfless beyond compare and generous to a fault. As I write this now, I'm proud to say that the OIF is not only better positioned to serve the needs of the OI community and uphold our mission, but thanks to each of you, our medical professionals, our Board of Directors and the entire staff at the OIF, we were able to turn that notion of uncertainty on its head.

From a support standpoint, each of you played pivotal roles in re-shaping the OIF into what it is today. Part of our commitment to re-imagining our role in the OI community was listening to each of you. We asked for your voice and we got it, in droves. Out of your feedback emerged community town halls and focus groups, along with virtual get-togethers and fundraisers. Late last year, the Geisman Family and the

OIF launched Gemma's Corner on YouTube. This collection of first-person stories chronicles personal journeys and successes from OI community members.

From a research perspective, we promised to change our approach and transparency when it comes to information, and we have. During OI Awareness Week 2021, we're launching a new "discovery series" featuring some of our most prominent medical professionals. We want you to be the first to know about new trends, discoveries on the horizon and the latest research. Throughout the year, we'll be hosting live town halls with some of OI's top investigators, like Dr. Brendan Lee, Dr. Deborah Krakow, Dr. Eric Rush and many others. We'll have open, candid conversations covering the most-requested topics, including pregnancy, pulmonary and dental. Recently, Dr. Laura Tosi shared eye-opening results from the first of two COVID-19 surveys commissioned by her tireless team at Children's National in Washington DC.

Between now and July 2022, we'll hold back-to-back national conferences for a total of three in three years. In addition to the customary conference topics, we'll be devoting a significant amount of time to address topical issues, including COVID-19. In 2022, we plan to gather again in-person, this time at the JW Marriott Grande Lakes Resort in Orlando FL. Stay tuned for more details as they become available.

A year removed from that quote, we now have a much better idea how great and how broad the impact on the OIF would become. And while the uncertainty wasn't unfounded, we also know the impact was unexpectedly positive. For that, we can only thank you!

Awareness and Education

On May 2-9, 2020, the OI Foundation organized its 11th annual National OI Awareness Week. OI Awareness Week was proclaimed in 26 states across the country. Volunteers participated in virtual fundraising events such as Bone China Tea and the OIF Art Auction. Throughout the week, more than 200,000 individuals were reached on social media and 90 OI community members created Facebook fundraisers to raise nearly \$20,000 to help support the work of the OI Foundation.



OIF Virtual Conference

After careful consideration, the OIF's Board of Directors and OIF Staff made the difficult decision to pivot the planned 2020 OIF National Conference to a 2-day virtual conference. Although we were disappointed to not be able to come together in person, the health and safety of the OI community comes first. The OIF Virtual Conference provided live online versions of 15 of the most popular informational and social sessions at the OIF National Conference to more than 900 participants from across the U.S., Canada, Europe, Africa and Australia – all free of charge. As a way to kick-off the OIF's Virtual Conference weekend, we held a *Virtual Unbreakable Spirit® Walk-n-Wheel* chaired by Mark Birdwhistell, Stephanie Greenwood and Dr. Maegen Wallace.

Rare Bone Disorder and OI TeleECHO Sessions

The OI Foundation and Rare Bone Disease Alliance's monthly Rare Bone Disease TeleECHO Clinics have been gaining popularity in the medical community both in the U.S. and internationally. Thanks to this success, the OIF launched the first OI focused TeleECHO series this year. This virtual continuing medical education platform will increase access to expert medical knowledge for participating physicians and medical professionals. This program will connect practitioners across the globe for monthly sessions that will include brief presentations and real-world case presentations focused solely on osteogenesis imperfecta. The OI TeleECHO Series will improve the ability of medical professionals to treat patients with OI.



Eugene Washington PCORI Engagement Award

Last summer, the OIF was approved for a funding award by the Eugene Washington PCORI Engagement Awards (Engagement Awards) program, an initiative of the Patient-Centered Outcomes Research Institute (PCORI). The project represents the OI Foundation's first step to engage the entire OI community in defining the critical aspects of living with OI across the lifespan. The goal is to develop a coalition of community and medical professionals who will direct and encourage new OI research. The project uses the OI Registry as one of several platforms for gathering insights from the community, allowing you to really tell us your story. OIF Information Center

This past year, OIF staff responded to more than 11,000 direct inquiries for medically verified information, and an average of 40,000 people used the OIF website each month. Topics range from medical issues such as genetics, diagnosis, and treatments to daily living strategies such as school and employment. Educational materials are available in print and electronically through the OIF website.

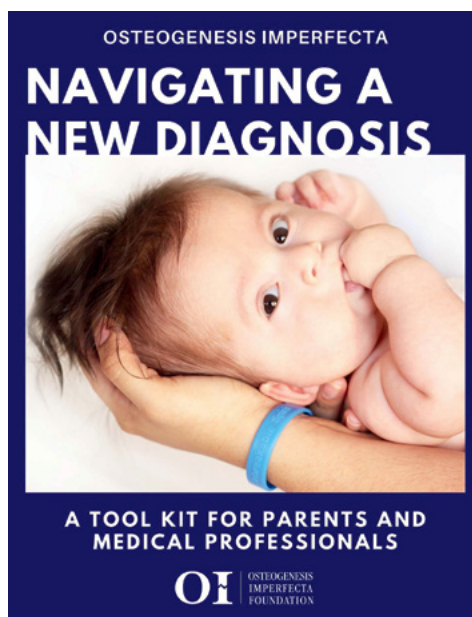

Impact Grants

In partnership with the Children's Brittle Bone Foundation, the Jeanie Coleman Impact Grant program was designed and established to provide funding for items that will significantly improve the quality of life for a person who has OI. This year, the OIF was able to fund more than \$100,000 of items and services including travel for surgery, hearing aids, new wheelchairs and physical therapy.

Navigating a New Diagnosis: A Toolkit for Parents and Medical Professionals

This tool kit, sponsored in part by a donation from Minnesota Neonatal Physicians in memory of Michael Johnston – a long time OIF volunteer and past board member – covers topics including diagnosis of OI, types of OI, caring for a newborn with OI, and information to share with your doctor. The *Navigating a New Diagnosis Toolkit* is available online and in print for OI community members, medical professionals, OI clinics, and bone health programs.



Social Networking

The OI Foundation manages three official social networking sites: the OIF Facebook Page – followed by 13,274 Facebook users; the OI Foundation Twitter page (@OIFoundation) – followed by 2,577 Twitter users, and the OIF Instagram page (@oifoundation) – followed by 1,215 Instagram users. This year the OI Foundation also launched the OIF YouTube channel highlighting virtual information sessions, COVID-19 community calls, and fundraising event recordings. A new series was created in honor of OI Foundation founder, Gemma Geisman, to share stories from OI community members. *Gemma's Corner* encourages the OI community to keep sharing with each other, caring for each other, and providing support to one another.

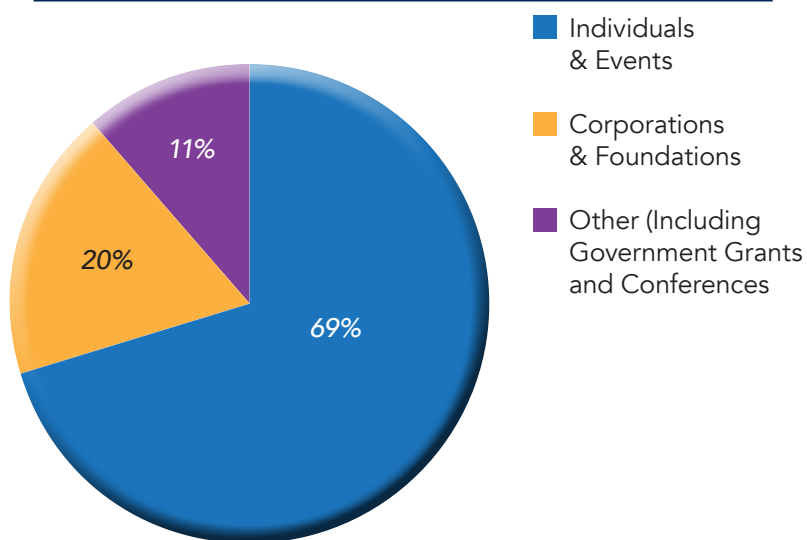

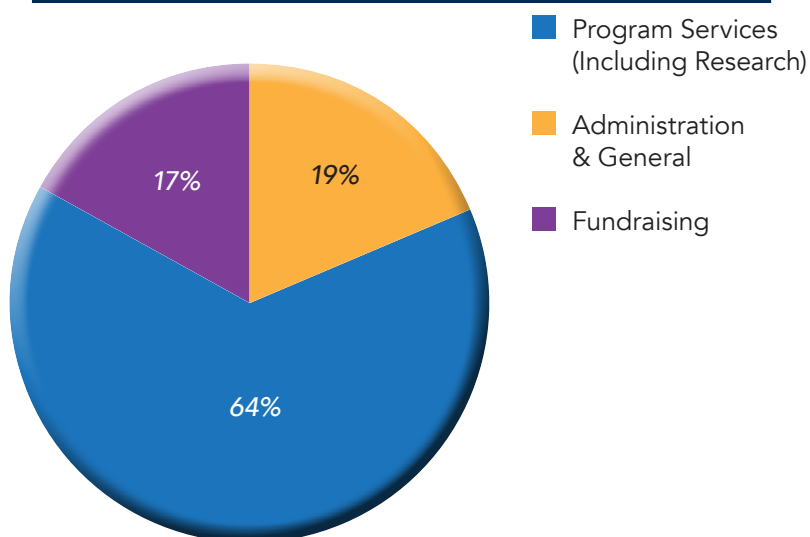
